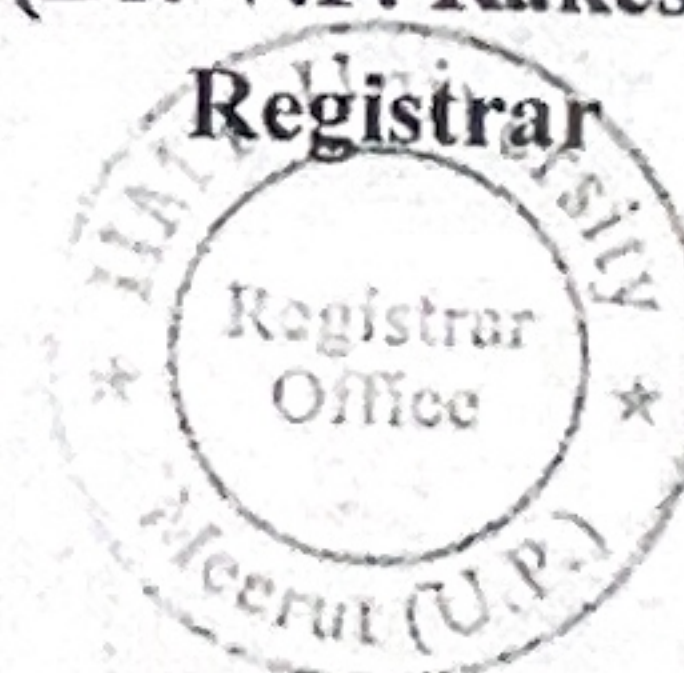
As per orders of the competent authority, a "Code of Conduct Committee" for the students is being constituted in the University. The members of the Committee are as follows:

## Office Order


A well formulated code of conduct symbolize an organization's mission, values and principles linking them with standards of professional conduct.
