## **Institutional Scholarship Policy**

The vision behind formation of this policy is to support and encourage the students who may be deprived of education because of financial short falls. In our society there are many families who have to suffer tragic moments resulting in carrier hindrance of the boys/girls belonging to such families. Even some students may have difficulties in going for higher studies. IIMT University wishes to help such students in the time of need so that their future may be bright.

The objective behind the creation of this fund is to provide financial help to the needy students as to continue their studies in their hard times which may have arisen because of the death of earning parent or serious medical issues. The policy also supports the students from time to time by giving them scholarship in fees either because of any sudden incident or in case of student going for higher studies. The committee may consider some special cases also falling behind the criteria of the policy. The scholarship committee shall have the authority to review the application and recommend names of eligible candidates for the award of a scholarship and/or tuition fee waiver, as applicable. The institutional scholarship policy will be granted for one year except adoption policy. In adoption policy, the scholarship is granted for full course duration. The Chancellor of the University shall have the final authority to approve the award of the scholarship.

#### 1. Merit Scholarship

Merit scholarships are given to students who achieve the good percentage in their higher secondary examinations. It is also awarded to students who achieve high percentage in their semester examinations.

#### 2. Sports Scholarship

Students who obtain certificates at the District/Division/State/National/International are eligible for this scholarship.

#### 3. Physically Challenged

Students suffering from physical disabilities are eligible for this scholarship.

#### 4. Economically Deprived

Students who belong to economically backward class/parents who are economically unsound are eligible for fee scholarship.

#### 5. Alumni

Students who have completed their UG degree at our university are eligible for admission to PG degree with scholarship.

#### 6. Freeship Policy

Students whose become parentless during pursuing any course and financial crises has arisen in the family, 100 % tuition fee scholarship is granted.

#### 7. Spinal cord injury

If student come across any spinal cord injury incident, 100 % tuition fee scholarship is granted.

#### 8. Adoption

If any student has come across very grave circumstances because of some natural calamities, 100% total fee including hostel, transport, library and course fee is exempted.

#### 9. Single girl child

A girl who is the only child of their parent and there is no brother and sister are eligible to apply for this scholarship.

#### 10. Medical Treatment Assistance-

If any student has come across any unwanted circumstances arisen because of adverse health conditions or has met with an accident, the committee may decide on giving financial assistance.
