3. Refund Policy (In case of cancellation of admission)

The refund of the fees is carried out as per the policy of refund of the fees as decided and prescribed by the UGC of the said academic year.

Category	Percentage of refund of Fees	Point of time when notice of withdrawal of admission is received in the HEI
1	100%	15 days or more before the formally notified last date of admission
2	90%	Less than 15 days before the formally notified last date of admission
3	80%	15 days or less after the formally notified last date of admission
4	50%	30 days or less but more than 15 after formally notified last date of admission
5	00%	More than 30 days after formally notified last date of admission

Admission Submission Policy:

1st Year Students (Fresher)	For Semester Courses	1. 40% of Total Fee (After Scholarship) + Uniform Fee at the time of Admission 2. 60% Fee to be submitted before begin of 2nd Semester or 31st January, whichever is earlier.
	For Yearly Courses	1. 40% of Total Fee (After Scholarship) at the time of Admission 2. 60% Fee to be submitted by 31st January.
2nd Year Onward (Old Students)	For Semester Courses	1. 60% of Total Fee (After Scholarship) before beginning of Odd Semester or 20 th August. Rest of 40% by 31 December.
	For Yearly Courses	1. 60% of Total Fee (After Scholarship) By 20 th August and 40% by 31 December.
Regarding Hostel Fee:	1. 50% of Total Hostel Fee to be submitted at the time of booking. 2. Balance of Total Hostel Fee by 31 st December.	
Regarding Transport Fee:	1. 50% of Total Transport Fee to be submitted at the time of booking of service. 2. Balance of Total Transport Fee by 31 st December.
